- Listen to others
- Give everyone a chance to speak
- Respect the ground rules
- Respect each other



## **GROUND RULES**

- Speak openly and honestly
- Listen carefully and respectfully to each person
- Keep comments brief and stay focused on task
- Explore differences respectfully and look for common ground
- **Trust** that the facilitator has the best interest of the group at heart
- Silence cell phones
- Be respectful of the opinions of others



IS LAW ENFORCEMENT ADEQUATELY ADDRESSING THE CONCERNS OF THE COMMUNITY?





- Shouldn't be "by the time they get to us" but ... "By the time we get to them." Public servants are part of the community.
- When kids see us at 2, 4, 6- they see friends, not fire or police officers.
- Take a step backwards so we can move forward
- The problems are going faster than we are as police officers
- How do we keep them (the kids) straight from the jump?
- We need way more fathers than police officers
- The men that I interact with are not here and they do not want to be
- When it was a neighborhood, everybody knew everybody. When it's a 'hood...
- Would it help to have (police) partners that look more like the kids you want to help? Yes.
- I don't address them as gang bangersthey are members of the community



- LA Gang Ceasefire: If they can stop for 21 days they can stop for longer.
- Have to change the image of what's in kids' heads: It's ok to talk to police officers, it's ok to talk to the minister.
- Instead of teaching Ray-Ray how to hold a sack, teach him how to read.
- Need a place Saturdays for community activities for kids- sports, piano, dance
- Helps to take kids out of the community, into a different environment
- Knowing your neighbors- huge in preventing crime
- Building relationships in the community- essential
- Bring back Neighborhood Watch to the district
- More foot patrols help build community relationships

- Ministers have gone out to the community to calm down protesters and their anger.
- I don't have a problem with protesting- buts it's the way people protest.
- One of the biggest downfalls of patrol no community engagement
- Not enough resources to take a patrol unit off to do community engagement instead. Patrol units get too many calls and then can't get to other (non crime related) activities.
- How do we recruit people who have been targeted to come to these dialogues?
- For someone who was targeted, they don't care about dialogues
- What can law enforcement do to bring tension down?
- Barbershops can be neutral meeting place
- There is a lack of education on both sides- community + LAPD

- Social media plays a HUGE role in what our young people believe.
- How do you help people heal who have been forced to view a murder on TV, after watching a murder in real life. They are traumatized by terror = media as terrorist.
- Both the community and police are overreacting to situations.
- Police need to be monitored as to their stress levels.
- Maybe shorter patrol shifts, or change it up sometimes patrol, sometimes community activities.
- Officers are willing to engage in community relations- we have lost a lot of what we had in the past.
- More foot beats help
- Who is keeping an eye on the mental health of police? Cops do have access to psychiatric assistance.
- Why are blacks and hispanics treated differently?
- I'm suspicious of the differences that I see in neighborhoods.
- Cameras only capture some of what is happening.

- Our community is not informed and not engaged, and not using media in a positive way.
- We get from the media that law enforcement only shoots to kill. It ups their ratings. The media is making it racial
- The media portrays a lot of negativity; South LA is always shown in a negative light. Community feels this is unfair treatment.
- The media airs murders. It's even on YouTube. Children and adults cannot deal with what they have viewed.
- Officers are not social workers
- Why can't you shoot to wound? Your training should be better.
- Officer says- we shoot to stop the threat.
- (Body)Cameras only capture some of what is happening.
- Officers get lost and forget the community aspect of their jobs (service). "I can't change the department but I can change how I behave with the community as an officer."
- We should have more respect for the police.

#### • Parents gotta be the backbone.

- Parents are in jail- kids model their behavior after their parents.
- School system needs to instill mandatory accountability.
- Community field trips and beyond are helpful- so kids can see what else is out there. Need more activities for kids, esp. in summer.
- Officers can educate one another on community policing. This will help to change the perspective from hurting to helping. People see that the police work for you.
- To police- why can't you smile? In the community we are human to human.
- Start building a relationship with our kids- they are our future.
- Police should explain what they do and why they do it. Establish a respectful dialogue between police and the people. To build mutual respect.
- Gun violence is a real problem
- False reports or lack of information... lead to a belief that a person has a gun.
- Who is accountable for the false report? Police, caller, person on the street...
- Homelessness a big problem. Mental illness is a big problem.
- LAPD need more training to deal with this. Then again, it is not their job...


- When children get a hold of a gun in the home, they play with it and do not know that it can kill. Responsibility within the home to take care of gun safety.
- Mental Evaluation Unit (MEV) gets involved when officers or family call for 72 hour hold.
- Officers need more mental health training beause mental illness calls are becoming more prevalent. And not just for homeless.
- What is the law, when it comes to homeless? Society has become numb to what is going on.
- What can community do to help with mental health problems?
- Officers get 8 hours of training "every so often"
- Mental health treatment for officers needs to be better.
- Community can do the Forced Eye Simulation to experience police point of view. Shows videos of killings.
- How many police come from within the community? Not many. That is the perception. Is this reality?
- Are there still community meetings? Yes: you can go to neighborhood watch, police citizen advisory board, Church community groups, block/neighborhood meetings. You can go to your police station and ask to speak to the community relations officers.

- Young black men can't take out the trash. Their mothers fear they will get shot just stepping outside.
- We need more faith based participation, assistance in filling the gap with the police dept.
- We need to push our schools & demand mandatory parenting classes.
- Need more dispute resolution training for parents, and ministers.
- Public needs to know how to react when encountering the policeneed education in this area.
- I'm interested in police training- your side. I know the public doesn't have a full understanding... I'm saddened by the deterioration of the relatinship between the cops and community over the years.
- Excited to come today because it is rare for police officers to have the opportunity to sit down at the table and just talk to the people.
























# POST-DIALOGUE SURVEY RESULTS 45 Respondents

HAVE YOUR OPINIONS CHANGED AS A RESULT OF THIS DIALOGUE?


