DAYS OF DIALOGUE IS... FACILITATED DIALOGUE

- Structured Conversation
- The facilitator acts as a moderator, rather than a leader and is always neutral
- The purpose is to share Thoughts, Feelings, and Experiences in a safe and confidential space



DIALOGUE PARTICIPANTS ARE ENCOURAGED TO...

- Express your opinions
- Listen to others
- Give everyone a chance to speak
- Respect the ground rules
- Respect each other



GROUND RULES

- Speak openly and honestly
- Listen carefully and respectfully to each person
- Keep comments brief and stay focused on task
- Explore differences respectfully and look for common ground
- Trust that the facilitator has the best interest of the group at heart
- Silence cell phones
- Be respectful of the opinions of others
















IS LAW ENFORCEMENT ADEQUATELY ADDRESSING THE CONCERNS OF THE **COMMUNITY?**





This is a wonderful opportunity – To be welcomed into the home of the LAPD to discuss community concerns and needs and to share our mutual experiences & perspectives.










People need to follow the program and obey the law.

Estuvo muy constructivo; hoy nos comprendieron. It was very constructive; today they understood us.






As a police officer, I want to have face to face conversations with the people in the community
