- Structured Conversation
- The facilitator acts as a moderator, rather than a leader and is always neutral
- The purpose is to share Thoughts, Feelings, and Experiences in a safe and confidential space



## DIALOGUE PARTICIPANTS ARE ENCOURAGED TO...

- Express your opinions
- Listen to others
- Give everyone a chance to speak
- Respect the ground rules
- Respect each other



### **GROUND RULES**

- Speak openly and honestly
- Listen carefully and respectfully to each person
- Keep comments brief and stay focused on task
- Explore differences respectfully and look for common ground
- Trust that the facilitator has the best interest of the group at heart
- Silence cell phones
- Be respectful of the opinions of others




### 1) What is your GENDER?





### **ETHNICITY**


### What is your Ethnicity? MARK ALL THAT APPLY


### What is your AGE?
















## HAVE YOUR OPINIONS CHANGED AS A RESULT OF THIS DIALOGUE?


















# WHAT, IF ANY, ACTION(S) DO YOU EXPECT TO TAKE AS A RESULT OF THIS DIALOGUE?

## **About Gun Violence** and Feeling Safe

There should be more gun governance.

Changing gun laws is a good idea but either way guns will get in.

There should be a better way to solve violence.

What can we do to make the government understand that it is not just about mental health issue but it's gun control?






It's not the guns, it's the people.

Some guns shouldn't be allowed to be purchased.

Gun laws need better checks and balances and restrictions on who can get a gun.





Why would they let someone at the age of 18 buy guns?

It was helpful to understand what can be stopped or can help.



Guns should be used for the right situation.

People should be more responsible when in situations in which guns are included.

People shouldn't own a gun if they don't know how to use it.





It was nice to talk about sensitive topics such as these and understand one another's opinions.

It is a problem and there has been no solution.

Gun laws should be changed, and make people know the consequences of their actions.





Teachers with guns- NO way. Some teachers are crazy- it's dangerous.

We have security officers. Teachers don't need guns.

Teachers should be able to get a gun but with major training.

Teachers should not have guns- even professional law enforcement freezes up. It is too much to expect.





Only one officer on campus and he has to stay in his office all day. this helpful?

Need guards at schools- to guard our most precious resources.

The Florida shooting has caused anger and anxiety.

I've been too scared to say something because I'm afraid something will happen to me.

To prevent shootings, add more police into schools. More cameras on campus.

Need more counselors.

What can we do to make the government understand that it is not just a mental health issue but it's about gun control too?

Make it more normal to seek counseling. So you won't be seen as abnormal if you go.





Students get bullied because there is mental illness.

Bullying causes major issues. Be careful how you speak to others because it matters and can affect them forever.

Assist those being bullied so they don't feel the need to retaliate.

Mental illness is an issue with police officers too. We all need to be aware of mental illness signs.





Metal detectors- mixed opinions. Some say they feel safer, but some say it makes them feel guilty, for having to be searched.

Schools need a drill to practice what to do during active shootings.

The school prepares us for earthquakes and fires but not for active shootings.



There should be a better way to solve violence.

It is important to take part in a political way to change gun violence.

High number of police never even draw a weapon.



I feel somewhat better. I have a better understanding about gun laws in California.

Everyone should be treated the same under the law.

Know an officer to contact for family to family violence.

Drugs impact the community. It's easy to get marijuana and people think it's ok to have it because it's legal.





If you see something, say something.

Why doesn't LAUSD do something to provide more protection?

LAUSD doesn't do anything when there is a shooting (just calls the home).

Be prepared——initiate LAUSD to host RUN/HIDE/FIGHT training. (Run/Hide/Fight Active Shooter One-Pager from FEMA http://bit.ly/2EV8Ziv)

2<sup>nd</sup> Amendment conflict – right to bear arms- how do we deal with this?

Have more supervision at entrance and backpack checks.

It's not the weapon but who carries it.

Background checks are not complete enough.
